RESEARCH NOTES – JAMES HASTWELL b.1818

This James (1818 to 1886), as far as is known, is the first of this Hastwell line to migrate to Australia.

James HASTWELL was born on 11th March 1818 in London and married Mary Ann ADSHEAD who was born on 28th March 1814. James died 2nd April 1886 aged 71 and Mary Ann died 21st June 1891 aged 77.

"(I) found on my friend's Ancestry site ... in the 1851 census, Mary Ann HUSTWELL, James (7) Ebenezer (6) John (4) and Baby Edward (9 months) Father James was not home - the census was marked "Husband Commercial Traveller." The address was 85 Vauxhall Street, Lambeth, Surrey. Didn't think to check the neighbours - will have to go back to it."

There were seven children altogether with the following being born at Black Friars in London: James born on 17th December 1843 and died on 5th January 1914, Ebenezer born on 25th May 1845, John born on 3rd April 1847 and died 16th June 1932 and Edward born on 25th May 1850 and died on 23 December 1857. Mary Ann was born on 23rd March 1853 in Lambeth, London, but she died just before the family embarked at Bristol for South Australia on 7th June 1853. Two children were born in South Australia: Mary Ann (named after Mary Ann who died) born on 8th January 1854 and died on 23January 1854 (only living a few days) and William Henry born 29th January 1856 and died 27th March 1924. James and his family settled on a property at Penfield, north of Gawler.

In the 1980's this diary was in the custody of Victor Harbor National Trust (South Australia) and was sighted by Wendy Baker who, recognising the family name, at that time copied the note attached to the exhibit, as follows:

"Journal kept by James Hastwell who journeyed with his family from Bristol to Port Adelaide in 1853 in the '*Cotfield*'. Capt. Waite. Subsequently it was used as a ledger in his shop.

- August 28 stormy head wind
 - 29 lost a deal of canvas
- September 09 Crossed the line
 - 10 Weather hot but not oppressive
 - 12 Shark hooked but got away
 - 14 Spoke to a Frenchman from Valparaiso
 - 15 Girl born to Mr Walker, 2nd cabin
 - 16 3 ships in sight"

MISCELLANEOUS SHIPPING.

During the voyage of the *Cotfield* three deaths have occurred. The first was that of a young girl who was very sickly when she came on board, and died of consumption. The next was that of the first mate, Mr. Kerr, who was in the habit of sitting on the rail with his feet over the side, and the ship having given an unexpected lurch while he was in that position he fell overboard, and all

efforts to rescue him were unavailing. The cabin boy was subsequently lost, having fallen from the misen [mizzen?]. As in the former case, every possible effort was made to rescue him, but without success.

The COTFIELD- Four of the crew have already absconded in the gig belonging to the ship. So noiselessly did they accomplish their design that it is said no one heard them. They have hitherto escaped detection."

Wendy's independent research is backed up by that of Sydney Hastwell in the following note: James Hastwell, his wife Mary Ann and children John (18 yrs) Ebenezer (20 yrs), James (22 yrs) were all baptised on Sunday 17 September 1865 as "adult receivers" at the Lord's New Church, Carrington Street, Adelaide SA. William Henry aged 10 yrs was baptised as a child receiver. The Rev. E.G. Day was the celebrant. It is almost certain that the main family photograph of James, Mary Ann and the four boys was taken on this occasion.

The Rev. Day's daughter Elizabeth Day had previously married James Hastwell's younger brother Edward John Hastwell on 25 February 1860. The Reverend Day was also associated with the family storekeeping business in conjunction with Elizabeth's brother Edward Day.

On his arrival home, after travelling a distance of about 20 miles, the fractured limb received the necessary attention at the hands of Dr. Doenau."

"James HASTWELL snr. Died at his son's residence (William Henry HASTWELL) AT Hoyleton from heart disease on 2 April 1886 aged 68 years and he was buried in the Auburn cemetery. At the time of death he was described as a retired merchant of Collins Street, Enfield. In the edition of the newspaper the *Northern Argus* (6 April 1886) under sub-section Hoyleton News 3 April 1886 appeared the following tribute:

'The township has just sustained a loss by the death of James Hastwell sen.. The deceased gentleman was President of the Mutual Improvement Society at the time of his death, and he was a staunch supporter of the Hoyleton Athletic Club. By his liberal and genial disposition he had gained a large circle of friends.'

His son William Henry HASTWELL is recorded in Sands and McDougall's directories as being at Hoyleton from 1886 to 1888."
